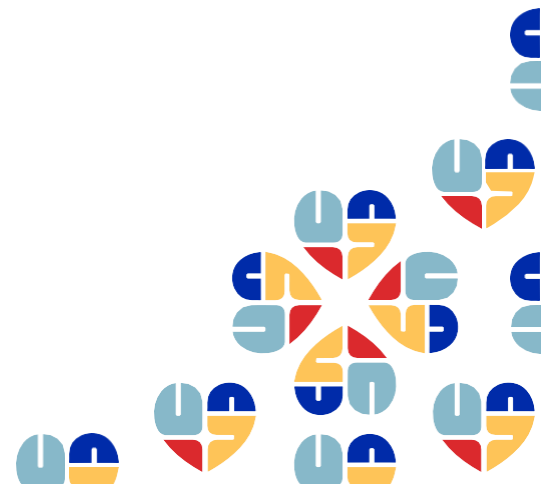
Shift has a Sex Worker Only Bad Date Forum. If you are interested in joining, contact Shift by email, phone, or twitter.

What is a bad date? A bad date is anything that you don't want others to experience. This includes an uneasy or creepy feeling about someone, theft, refusal of payment, threats, and all acts of violence and aggression.

Shift provides support services to adults of all genders who are working (or have worked) in the sex industry. We have a harm reduction and rights-based approach to sex work: this means that the safety and human rights of sex workers are our focus. Our support is here for those wanting to continue working in the industry, leave the industry, or anything in between. We have **peer support available** in one-on-one or group settings (dependent on demand)- get in touch for details.

This incident occurred in Red Deer

Date of Incident: March 16, 2026

Date Reported to Shift: March 16, 2026

Description of Event: Client contacted worker with his budget and said he was 30 minutes away from town, worker offered a half hour incall session and requested that the client either send a selfie with the current date and time or a deposit for the session. Client read the message but did not respond. He called 3 times and then sent a photo and a message saying he was 2 minutes away. Worker had a bad feeling and said she would not see the client. Worker recognized the individual as the perpetrator of a separate incident where the date tried to lure the worker to a remote acreage.

Description of Date: White man

Date Reported to Shift: March 13, 2026

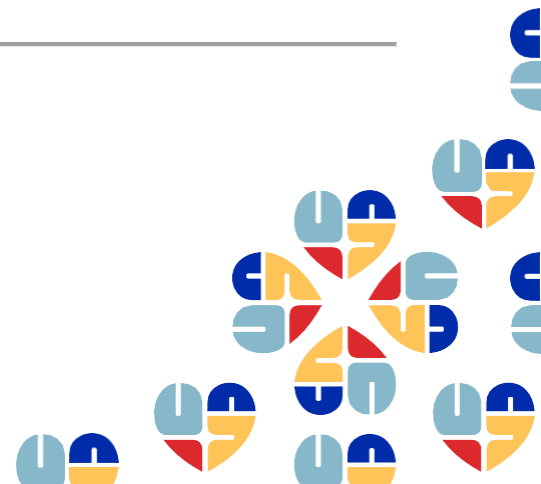
Description of Event: Client connected with worker through online ad and booked an overnight outcall. Client did not adhere to session guidelines and sexually assaulted the worker. Worker attempted to obtain the full amount owing and leave early due to the treatment, client said he would only pay the worker if she stayed the night.

Description of Date: Black man in his early 40s. Roughly 5'9" and an athletic build. Brown eyes, dark brown chin length dreads with grey sprinkled throughout. Reports working for a food distribution company from Regina.

Date of Incident: February 24, 2026



Date Reported to Shift: February 25, 2026

Description of Event: First time client contacted worker from online ad. Client obtained worker's legal name alleging that it was required to send an etransfer. Client and worker met in an out-call location. Client then sent a fake etransfer notification to the worker. When the worker found that there was not a deposit, the client 'called his bank' but worker suspects it was not a genuine call to a bank. Worker left the location after 45 minutes of non-payment.

Description of Date: White man in his late 40s to early 50s. light brown hair with curls, heavily tattooed right arm with an iron cross tattoo on his right upper pec.

This incident occurred in Red Deer

Date of Incident: February 12, 2026

Date Reported to Shift: February 12, 2026

Description of Event: Regular client requested 15 minute full service session. Worker was feeling ill and fainted while providing services. Client walked over the worker and grabbed the cash payment. Client gave the money back and quickly left when the worker grabbed their phone to call for help.

Description of Date: White man in his early to mid 30s, 6' tall and large bodied. Hair is light coloured, short and straight. Blue eyes.

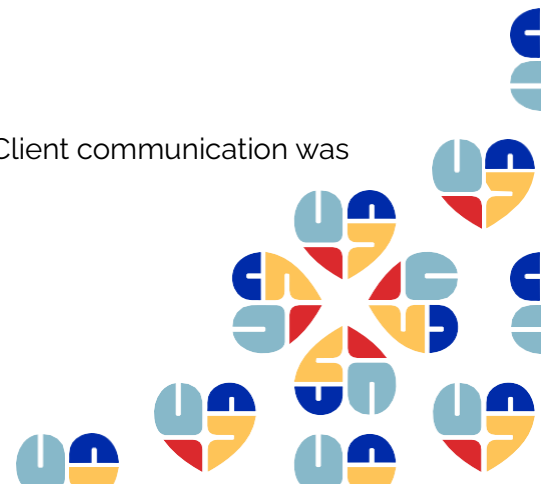

Date Reported to Shift: February 6, 2026

Description of Event: Client reached out to worker from her website. Client communication was



crude and requested services that are not offered by the worker. An appointment was made, when the client said he was around the corner he asked worker to call, worker told the client that she does not have a calling feature on the app she uses for work. Client insisted that the worker call from her personal phone, she asked him not to order her around. He proceeded to make rude comments followed by descriptions of the worker's legal name, old photos of her, and descriptions of her personal life. Client insists that he knows the worker but the worker does not know who he is.

Description of Date: White man in his early to mid 30s, has a tattoo of a goat skull on his right thigh.

Date of Incident: January 20, 2026

Date Reported to Shift: January 20, 2026

Description of Event: Client reached out to worker online stating that he was brand new to accessing services. Worker told client they do not see first time clients, the client immediately called the worker a 'whore' and said 'good luck making money'.

Description of Date: Approximately 30-35 year old male.

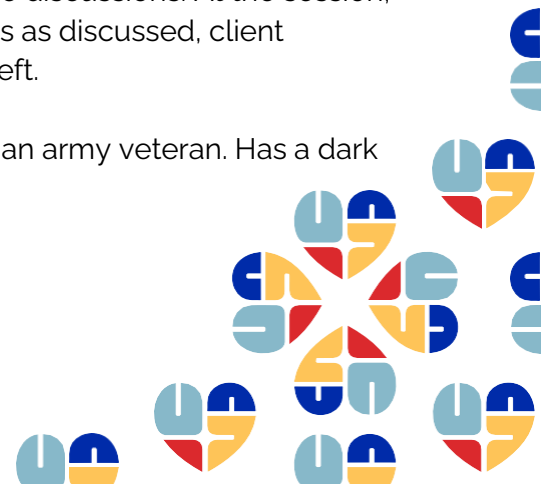

Date of Incident: January 11, 2026

Date Reported to Shift: January 15, 2026

Description of Event: Client contacted worker from an ad site and communicated as if he was offering a sugaring arrangement. Requested full service out call for first meeting. Boundaries and rates were discussed prior to the session. Client was respectful in these discussions. At the session, client refused to use a condom, worker reminded him of the conditions as discussed, client dismissed same and assaulted worker. Client took worker's cash and left.

Description of Date: 48 year old white man, large build, reports being an army veteran. Has a dark



brown beard with a vertical strip dyed white. Moderately tattooed, a snake tattoo on his right calf.

Description of Vehicle: Dirty white 2023 Honda CRV with a Tesla motor in the back.

Date of Incident: November 8, 2025

Date Reported to Shift: November 8, 2025

Description of Event: Client requested an in person outcall to a rural area. Worker told him that they do not offer services in rural areas. Client told worker that he was a repeat client, and that he has been to the worker's in call before. Client declined worker's offer for in call services. The client did not provide identification or other proof that he was a repeat client, he did not provide these. Worker reports that there is talk of a man who targets workers in Red Deer and assaults them at a rural property.

Description of Date: White man with a business in Leduc.

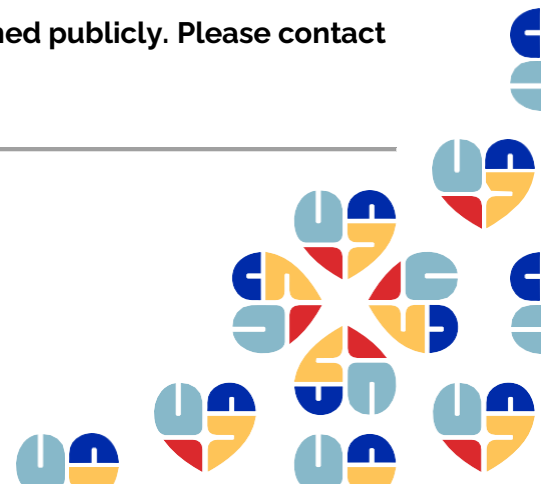
Date Reported to Shift: November 2, 2025

Description of Event: Client requested topless cuddling session, ghosted the worker on the day of booking after the worker booked the outcall space.

Description of Date: 40 year old white man, slim, average height, short brown hair

Date of Incident: October 10, 2025

Date Reported to Shift: October 11, 2025

Description of Event: Client contacted worker online. He booked a full service session and sent an etransfer screenshot to the worker. This transaction was fake and the client did not end up paying the worker, owing over 2K for the session.

Description of Date: 39 year old white man, roughly 5'8" and 230 lbs. Bald and has light brown eyes.

This incident occurred in Red Deer

Date of Incident: October 3, 2025

Date Reported to Shift: October 4, 2025

Description of Event: Date requested full service session. As soon as the client was let into the worker's in-call building, he started to grab at them. Worker asked him to stop, he continued to grab at the worker in the elevator and in the in-call. Worker asked date to leave after he continued to disrespect the boundaries set during the session. Date said he should get to stay as he had paid the worker, the date did not leave until the worker threatened to call law enforcement.

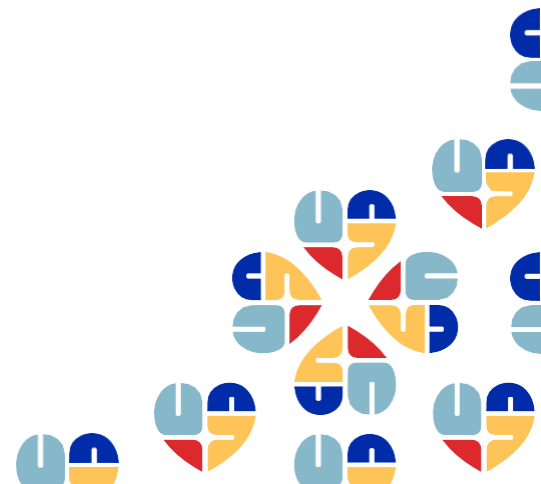
Description of Date: White man in his 60s, Torrington resident, over 6' tall. Wears short grey hair.

Date of Incident: October 1, 2025

Date Reported to Shift: October 4, 2025



Description of Event: Regular booked full service session with worker. Date started getting rough and requesting services that the worker could not do because of his size. Worker asked the date to leave as they were feeling uncomfortable with the challenging of boundaries. Date got angry and insisted that he should be able to achieve orgasm before leaving. Worker said they were 'not a blow up doll' to which the date replied that they should 'get a new job'.

Description of Date: White man in his 30s, large bodied and roughly 6 foot tall.

This incident occurred in Grande Prairie

Date of Incident: September 23, 2025

Date Reported to Shift: September 24, 2025

Description of Event: Date requested oral services and initially the session proceeded without issue. He then requested to extend the session to be full service. Once the worker had had a drink, the date began pushing boundaries that had been previously set, including types of service and barriers used. He proceeded with activities that were not adhering to the conditions previously discussed (assault). The worker was in a state of shock and told the date to leave, he did so and stated that he would send the fees by etransfer. The worker texted the date as payment had not come through, the date claimed he would give the worker cash but then ceased all communication with the worker.

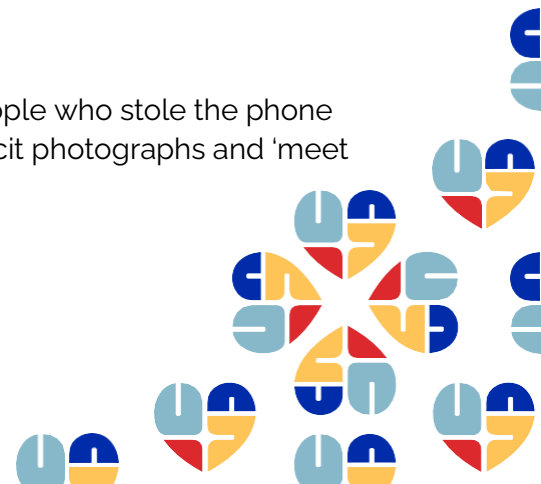
Description of Date: White 30 year old man, roughly 5'7" and 200 lbs. Has black hair and a widow's peak with some thinning at the top of the head. Hazel or brown eyes, and a 'bad tattoo' on his left arm as part of a full sleeve.

Date Reported to Shift: August 30, 2025

Description of Event: Worker's boyfriend's phone was stolen. The people who stole the phone attempted to impersonate him to try and get the worker to send explicit photographs and 'meet



up'.

Description of Date: Two Indigenous men in their late 20s. One man had a small mole on his left cheek above nasal crease. One wore a gold chain.

This incident occurred in Red Deer

Date of Incident: August 22, 2025

Date Reported to Shift: August 22, 2025

Description of Event: Client met worker online. Client requested full service, he did not have the full payment, so the worker agreed to a lower price for adjusted services. The client demanded extra time and services despite the worker saying no on several occasions. Client grabbed at the worker and said he couldn't understand English well enough to understand 'no', but was fluent in conversation otherwise. Client left when worker threatened to call the police.

Description of Date: Black man in his late 20s, thin build around 5'10", brown eyes and black curly hair.

Date of Incident: August 4, 2025

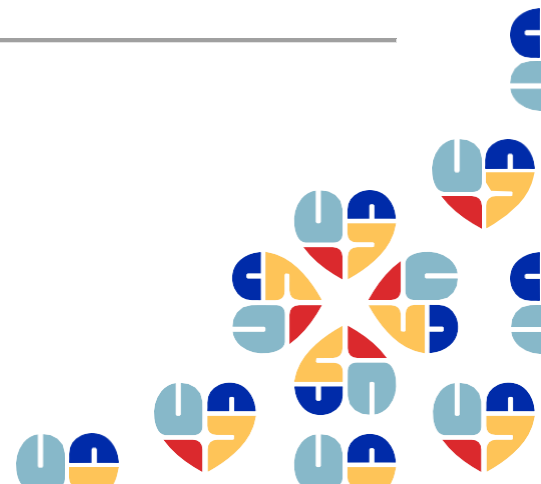
Date Reported to Shift: August 5, 2025

Description of Event: Client contacted worker online to request a video session. The client offered to send a deposit prior to the session, the email sent was a fake e-transfer scam with intent for the user to click a link to obtain sensitive information.

Date of Incident: May 2024



Date Reported to Shift: July 20, 2025

Description of Event: Regular client of the worker booked a 4 hour session at an in-call space. The client was generally creepy and wastes time. At the session, client stealthed worker.

Description of Date: 50 year old white man, roughly 5'7" and 200lbs, bald or very thin hair with brown eyes. Reports being a school principal.

This incident occurred in Red Deer

Date of Incident: July 11, 2025

Date Reported to Shift: July 11, 2025

Description of Event: Client contacted worker online. He requested an immediate appointment, worker let him know that they weren't available. Client demanded to know the worker's address and started spamming their phone with calls and 'creepy' messages. Client responded to worker threatening to call law enforcement with laughter. Client threatened to similarly harass other sex workers in Red Deer.

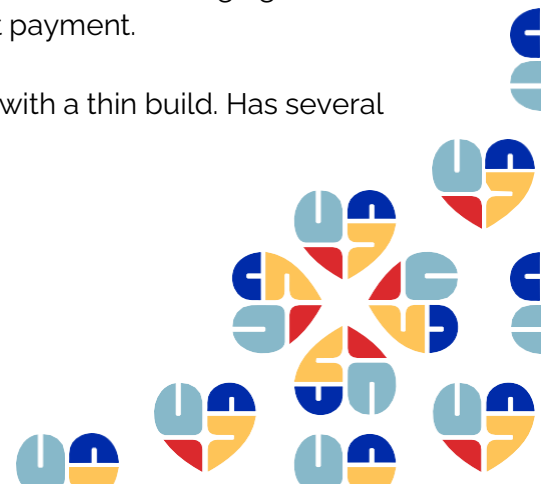
This incident occurred in Grande Prairie

Date of Incident: June 25, 2025

Date Reported to Shift: June 25, 2025

Description of Event: Client booked with worker online requesting a 2-3 hour session. Worker was stealthed during the session. Following the session, client told worker that he was bringing them to the ATM in the lobby of the hotel, pushed worker out the door without payment.

Description of Date: White man in his late 20s/early 30s, roughly 5'9" with a thin build. Has several different tattoos, brown hair and eyes. Works in the oil fields.

Date of Incident: June 16, 2025

Date Reported to Shift: June 16, 2025

Description of Event: Regular client booked an hour appointment for an agreed upon price, a deposit was paid. During the session, client reported satisfaction with services provided, however at the end of the session the client cancelled the e-transfer with the rest of the payment amount stating that he 'didn't get the experience he was looking for'.

Description of Date: Pakistani man of about 19/20 years old. Slim build with dark brown eyes and black hair.

Description of Vehicle: Infiniti vehicle.

This incident occurred in Grande Prairie

Date of Incident: May 17, 2025

Date Reported to Shift: May 17, 2025

Description of Event: Client met worker online and requested longer full service session. Client went to worker's in-call space without having cash. Client offered to get cash at the ATM in the building lobby after the date. After the session, worker and client went to the lobby to locate an ATM. When the worker approached the front desk of the lobby to ask about the location of the ATM, the client ran out of the building and got into an Uber that he had ordered while using the restroom during the session.

Description of Date: 27 year old white man, roughly 5'8" 160 lbs. Hair is brown and roughly 1" long. Acne from working in the oilfields. Several tattoos, mostly non-professional, include FFTP on knuckles, roman numerals, and an amateur Joker tattoo.

Bad Workplace Report

Date of Incident: Ongoing

Date Reported to Shift: May 16, 2025

Description of Events: Reports of several bad dates and an exploitative agency owner have come to Shift regarding an agency in the Beltline area, near Cowboys Casino. Report indicates the following are occurring at this agency by the owner:

- Audio and video recording of break rooms.
- Discouraging comradery and social connection between workers.
- Discouraging direct communication between workers and clients.
- Workers being blamed for client behaviour, including assault.
- Posting pictures of workers that were specifically requested to be omitted from advertising.
- Pressure for workers to see clients and charge rates that are not aligned with worker comfort.
- Withholding pay and retroactively charging studio fees.
- Insistence on knowing personal information about workers regarding their personal dating/home lives.
- Insults, belittles, and demeans workers.
- Threats to out an ex-employee and release false information regarding their STI status.
- Insistence on certain services being offered.
- Taxation of tips.
- Harassment of workers while they are not at work.

We are posting this report to encourage informed employment decisions for all sex workers considering an agency.

Date Reported to Shift: May 16, 2025

Description of Event: Client met worker at an agency near cowboys casino. Worker reports that the client has a pattern of requesting doggy-style services followed by the condom 'mysteriously' breaking.

This incident occurred in Montreal. Worker reports the date resides in Edmonton.

Date of Incident: January 28, 2025

Date Reported to Shift: May 1, 2025

Description of Event: Date requested a 24 hour booking. The date itself went smoothly with appropriate communication before and during. Payment and rates were discussed at length. The Date provided roughly 1/3 of the agreed upon rates following the date, and has refused to pay the full amount.

Description of Date: White man of roughly 40 years old, about 6' tall. Has blue eyes and short dark hair with greying parts. Heavily tattooed.

Date of Incident: April 27, 2025

Date Reported to Shift: April 29, 2025

Description of Event: Date requested a meeting with the worker through an agency. He pressured worker into taking videos and photos of them and the date continued to do so without permission. Date refused to use a condom. Worker reports date has creepy vibes and explicitly refuses to respect boundaries.

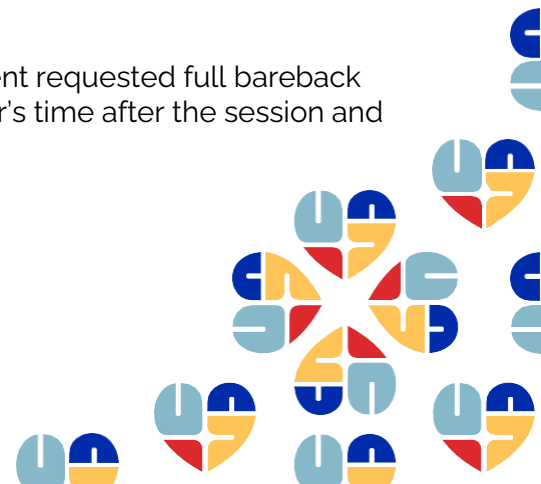
Description of Date: White man in his 50s, reports working in finance. "Average" build. Balding at top, wears hair long along the sides of the head and has white hair often kept in a ponytail. Grey eyes.

Date of Incident: March 31, 2025

Date Reported to Shift: March 31, 2025

Description of Event: Client contacted worker from online ad site. Client requested full bareback service. Client paid for a half-hour session, proceeded to waste worker's time after the session and



attempted to add more services for free. Worker and client got into a physical altercation, worker was able to protect themselves and the session ended.

Description of Date: Black man in his early 20s, 6'2" with lean/lanky build. Low fade afro, brown eyes. Possibly has a scar on his head.

Additional identifying details were provided that cannot be published publicly. Please contact Shift for these details.

Date of Incident: March 30, 2025

Date Reported to Shift: March 31, 2025

Description of Event: Client contacted worker from an online ad. Client requested full service for 4 hours. During the session, worker vocalized several times that they were in need of a break but client did not listen. Client was under the influence and was aggressive. Client reported having transferred the payment and worker received what looked like confirmation of e-transfer. After leaving the session, worker found that it was a fake e-transfer confirmation that was sent and worker was not paid for the session.

Description of Date: 37 year old white man, 5'9", has short red hair and blue eyes. Has a large tattoo on his left leg which goes all the way down.

Additional identifying details were provided that cannot be published publicly. Please contact Shift for these details.

Date of Incident: March 17, 2025

Date Reported to Shift: March 19, 2025

Description of Event: Worker met client on Stroll. Client offered to let the worker stay at his place with 'no strings attached'. Client offered substances to worker and said that worker 'owed' him sexual services. Client reports that worker engaged in services several times but worker has no memory of most of these services. In the morning, the worker was accused of stealing cutlery and electronic cords. Worker was never paid for services. Worker suspects that client is targeting workers who may present as having no home or having a substance dependency.

Description of Date: White man in his 50s, roughly 6' with a slim/lanky build, 'military style' grey haircut, green/blue eyes.

This Incident Occurred in Clairmont

Date of Incident: March 9, 2025

Date Reported to Shift: March 11, 2025

Description of Event: Client was referred to worker and requested services for him and his friend as back to back sessions. While worker and client were together, the friend left. When session was complete with the client and he saw his friend was gone, he overstayed with worker and attempted to get out of paying. When worker asked about payment, client proceeded to make threats to the worker and saying that he was going to be sending people to their home.

Description of Date: 5'7" 32 year old white man, thin build, wears ear length brown hair, brown eyes. Has a tattoo on his left shoulder.

Additional identifying details were provided that cannot be published publicly. Please contact Shift for these details.

This Incident Occurred in Lethbridge

Date of Incident: January 19, 2025

Date Reported to Shift: January 22, 2025

Description of Event: Client contacted worker online and booked a degradation/domination session. He told the worker that he e-transferred them, but payment was never received and the client ghosted the worker after the session.

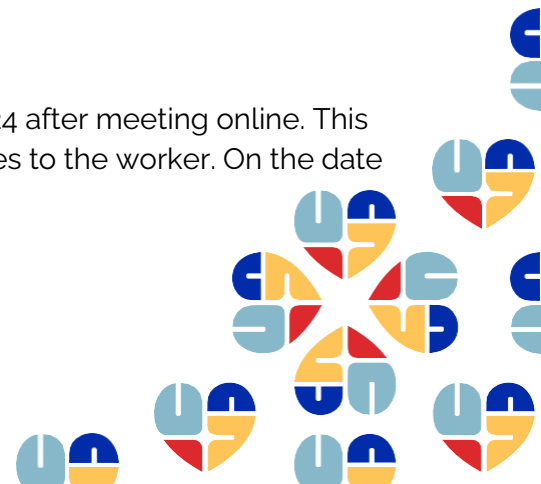
Description of Date: 35 year old Japanese and Indigenous man. Roughly 5'5", has long black hair, brown eyes. Wears broken glasses.

Date of Incident: December 22, 2024

Date Reported to Shift: January 14, 2025

Description of Event: Worker started seeing a client in summer of 2024 after meeting online. This client gradually began to push boundaries and offering free substances to the worker. On the date



of this incident, the client brought the worker, who primarily works from out-call spaces, to the Stroll and booked a hotel room for them to bring clients to. He insisted that the worker find clients on Stroll and work from the hotel with a large portion of the earnings being given back to him. Worker was at the hotel and told the assailant that they wanted to be brought home. The assailant was driving the worker, but was not going the route to return the worker home. Assailant sexually assaulted the worker while in the vehicle. The assailant photographed the assault. The assailant brought the worker back to the hotel where the worker remained until they were able to contact their partner.

Description of Date: West Asian man in his late 30s-early 40s. Roughly 5'7", slim athletic build. Wears a short beard, salt and pepper colouring, groomed. Speaks Farsi. Owns a pizza shop.

Description of Vehicle: 10-15 year old dark sedan.

Date of Incident: December 20, 2024

Date Reported to Shift: January 14, 2025

Description of Event: Client booked worker for out-call services. Worker arrived to the address, the client grabbed the worker by the throat and slammed them into the wall. Worker was able to escape.

Description of Date: Black man in his mid-late 30s. 6'2", broad shoulders and large, muscular build.

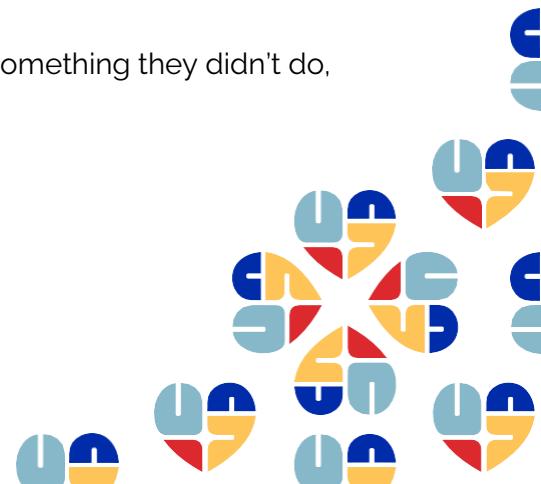

Description of Event: Over the phone, client was accusing worker of something they didn't do, threatened them with violence, and stalked the worker at their home.

Date of Incident: December 20, 2024

Date Reported to Shift: December 20, 2024

Description of Event: Date contacted worker online and requested full service session. During the session, the date removed the condom without consent. He told worker that this wasn't the first time he had done this during a session with them. When the worker asked him to leave, he threatened the worker and would not leave until the worker called their neighbour to come support. After leaving, the date continued to text and call the worker with threats of violence.

Description of Date: 41 year old white man, 5'10" with green eyes. Has brown hair at a medium length with side-swept bangs. Reports being married and has a son.

Description of Vehicle: White four door Ford truck with extended cab, model between 2020-2022.

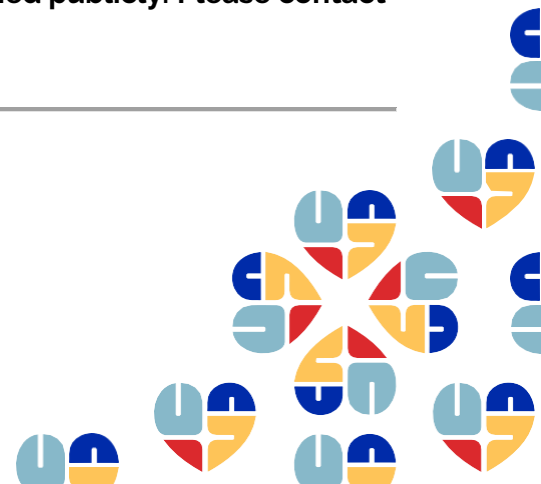
Date of Incident: December 3, 2024

Date Reported to Shift: December 4, 2024

Description of Event: Date booked and attended an hour session and sent a scam email to the worker. This email was claiming to be an e-transfer, but the worker has auto-deposit and immediately recognized this as a scam email intended to acquire banking information from the recipient. The email claimed to be coming from Scotiabank.

Date of Incident: November 29, 2024

Date Reported to Shift: December 1, 2024

Description of Event: Client contacted worker online and booked an outcall session. When the worker arrived to the location, client claimed he was locked out of his unit and requested to take the call in the laundry room of the apartment building. Worker refused. Eventually the client said his roommate had returned so they could go into the unit, worker left after client didn't want to pay upfront.

Description of Date: 25 year old Indian man, roughly 5'7", 165 lbs with thin build. Brown eyes and black hair with a trimmed beard. Reports he works for Rogers.

Additional identifying details were provided that cannot be published publicly. Please contact Shift for these details.

Date of Incident: October 20, 2024

Date Reported to Shift: November 21, 2024

Description of Event: Worker reports that 3 men attempted to lure her into their vehicle while she was in front of Winks in Forest Lawn. She reports that a man on a bicycle and another man on foot approached her while waiting for the bus. A car then drove up to her while she was waiting and said he was an uber and could offer her a ride, substances, and a weekend of partying. Despite her declining, they all continued to try and convince her to enter the vehicle rather than waiting for the bus.

Description of Date: 3 South or West Asian men, all in their early 30s. One driver, one pedestrian, and one cyclist.

Description of Vehicle: Red 2006 2-door Honda Civic.

Date of Incident: June 2024

Date Reported to Shift: November 8, 2024

Description of Event: Client stealthed worker during a session. Client reports travelling frequently



and is based out of Seattle. His phone number contains a Seattle area code.

Description of Date: 6 foot tall white man in his mid-30s.

Additional identifying details were provided that cannot be published publicly. Please contact Shift for these details.

Date of Incident: October 2024

Date Reported to Shift: November 4, 2024

Description of Event: Client was a trusted long-time regular of worker. He booked an overnight session which the worker which was discounted at his request. At a previous session, the client had asked for bareback services but the worker reminded him that they require condoms for all services, client acknowledged this. At the overnight session, the client stealthed the worker. The worker found a way to leave the session, communicated to the client later in the evening that this was assault and that their trust and relationship with this client has been damaged. When discussing ways to move forward, the client began to call the assault an 'accident', attempted to use emotional manipulation on the worker, and told the worker that they needed to 'own their part' of the assault.

Description of Date: 29-year-old Southeast Asian/Pacific Islander man. Has curly shoulder length hair and a beard. Has arm and chest tattoos, wears a gold chain. Roughly 5'6 with an athletic build. Is known to be active on industry websites.

Description of Vehicle: Silver Volkswagen Jetta.

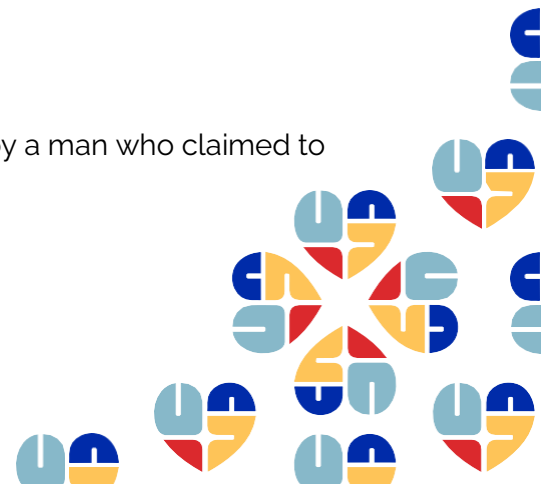

have seen them at a local bar. Worker asked the man to stop texting them, the man continuously harassed them until the worker threatened to contact law enforcement. Worker does not know who this man is.
